**Rules and Regulations**

- Picnic Permit Conditions: (Daily)
- \*\*Hours of Operation 8:00 a.m. – 6:00 p.m. Permit valid for specified date(s) only;
  - \*\*Individual must have a valid photo ID and permit in their possession as verification of their assigned areas;
  - \*\*No overnight camping(unless approved); and No Lifeguard on duty;
  - \*\*Launching of boats and jet skis are prohibited; Authorized area for launching is at Seaplane Ramp
  - \*\*Existing trees and shrubs must not be damaged;
  - \*\*Barbeque fires must be extinguished prior to vacating premises;
  - \*\*All users authorized shall not enter, damage or disturb leased facilities nearby;
  - \*\*Roadways must be clear of vehicles at all times for emergency responders;
  - \*\*Erections of canopies/tents are prohibited on the beach front;
  - \*\*Water slides/jumpers can be used at Port Beach upon approval by the GM. Additional fees will be assessed for water usage.
  - \*\*No utilities are available at Family Beach. User must provide portable power/water supply if necessary for Family Beach;
  - \*\*For Emergency purposes please contact PORT POLICE 477-5931 ext. 202/235, 477-2864 or 472-2703;
  - \*\*Permit cannot be transferred for the use of other Port properties;
  - \*\*All trash must be removed from the premises upon departure. Failure to comply will forfeit cleaning deposit, and/or user may be **BANNED** from future use.\_\_\_\_\_
  - \*\*Beach Fees will be only be refunded when cancelled two (2) business **days prior** to date of activity.\_\_\_\_\_
