PAG Docket 17-01 5-Year Tariff Increase

On April 27, 2017, the Guam Public Utilities Commission (PUC) approved the Port Authority's 5-Year Tariff request.

The second year rate was implemented on January 1, 2018. All Tariff rates increased by 7% to exclude Crane Recovery Charge (CRC), Fuel Storage, Throughput and bunkering Fees.

The third year rate will be implemented on October 1, 2018. All Tariff rates will increase by 1% to exclude Crane Recovery Charge (CRC), Fuel Storage, Throughput and bunkering Fees.
